

PERSONAL DATA PROCESSING NOTICE

1. i&i Prague, s.r.o., with its registered office at Flemingovo náměstí 542/2, Dejvice, 160 00 Prague 6, ID No.: 06058485, registered in the public register kept by the Municipal Court in Prague section C, insert 275316 (hereinafter referred to as "Controller" or "i&i Prague"), processes your personal data in accordance with the following terms and conditions: Controller has the meaning within the meaning of Regulation (EU) No. 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter referred to as "GDPR")

Principles of processing:

2. The Controller adheres to the following personal data processing principles:
 - a) lawfulness, fairness and transparency in relation to the data subject,
 - b) all data are collected for specified, explicit and legitimate purposes set forth below;
 - c) the controller only collects and processes data that is adequate, relevant and limited to what is necessary in relation to the purposes for which they are processed;
 - d) all data are accurate and, where necessary, kept up to date;
 - e) the data are processed and stored only for the time necessary;
 - f) the controller processes the data in a manner that ensures appropriate security of the personal data.

Scope of processing of your personal data:

3. The Controller will process your personal data to the extent that you have provided it in connection with Prague.Bio Conference. The Controller will especially process:
 - the identification data and contact inserted into the form on www.prague.bio website,
 - electronic or written communication with the data subject.

How the Controller obtains personal information:

4. Legal basis for collecting and processing your personal information are stated in part 3 of our [Privacy Policy](#), which can be found on our website.
5. The Controller obtains personal data directly from the data subject during registration,
6. The Controller will process your personal data in connection with the purpose for a period of 2 years after you have given your consent to the Controller.
7. The provision of personal data is voluntary. You can withdraw your consent at any time, free of charge, by sending an email to info@iniprague.com.

Transfer of data to third parties

8. The processing of personal data is carried out by the Controller; however, the following processors may also process personal data for the Controller:

 - c. other providers of processing software, services and applications, but not currently used by the Company.

Rights of the data subject
